ANNUAL REPORT FOR 2014

Personnel

Northern Community Mediation (NCM) has three, full-time employees: two Intake Coordinators and the Executive Director. Intake Coordinator Terri Sevener has been with NCM for almost three years. She is responsible for general civil, domestic relations, and guardianship cases. She also oversees the School Attendance Mediation, Child Protection and Victim-Offender Reconciliation ProgramS. Dixie Bunker began working for NCM in October 2014. She is responsible for all small claims, landlord / tenant, divorce with children and divorce without children cases. Dixie replaced Assistant Director Bert Rousseau, who had been with NCM for nine years. Dr. Jane Millar has been the Executive Director of NCM since July 2003.

With Bert Rousseau's resignation, NCM sought her replacement. Over 50 applications were received. The Executive Director interviewed five individuals for the position.

In addition to the paid staff, NCM has 59 volunteer mediators. The majority of the volunteer mediators have received advanced training in specialized fields of mediation. The table below depicts the areas of expertise along with the number of mediators qualified in those fields.

As can be seen, NCM has a sufficient number of mediators. The challenge facing NCM relates to the availability of the mediators. Many are retired or work full-time. Hence, they are either traveling or only available on a limited basis for daytime mediations. Additionally, more and more of the cases referred to NCM are complex and require specialized training.

NCM enforces the State Court Administrative Office (SCAO) requirement that mediators complete a minimum of eight hours of continuing education every two years. NCM also continues to be in compliance with the State Court Administrative Office (SCAO) policy for background checks. All employees, interns, volunteer mediators and other volunteers must undergo a background check through the Michigan State Police (ICHAT), as well as a criminal registry check through the Department of Human Services every two years.

Trainings and Workshops

In 2014, NCM hosted four Mediator Roundtables relating to school attendance, victim-offender reconciliation, child protection, and parenting time. In addition, NCM collaborated with the Charlevoix-Emmet Intermediate School District to facilitate a training relating to the district-wide School Attendance Mediation Program.

Attorney and mediator Steve Tresidder facilitated an Advanced Mediator Training entitled *Social Psychological Factors in Mediation* ON May 16. There were 52 participants.

On June 21, Dennis Mac Donell, who is the Court Security Specialist for the Michigan Supreme Court, conducted a three-hour security workshop. His agenda covered the following topics: court security, personal safety, powers of observation, potentially violent situations and bomb threats. All of this was directly related to mediation and the facilities available to NCM. In addition to the workshop itself, Mac Donell made several, specific recommendations to ensure greater safety of NCM staff and mediators.

NCM staff participated in professional development opportunities offered at sites other than at NCM. Terri Sevener attended the Michigan Association of Court Mediators (MACM) annual conference as did Assistant Director Bert Rousseau. Terri also attended the Little River Band of Odawa Peace Making Conference.

Meetings & Gatherings

In addition to regular meetings relating to the operations of NCM, the staff participates in a variety of specific meetings.

On January 16, 2014, NCM conducted its annual meeting for 2013. It was held from 12:02 pm to 12:45 pm at Palette Bistro in Petoskey, Michigan. Minutes of the 2014 annual meeting will be available on the NCM website (www.northernmediation.org) upon approval of the Board of Directors at the 2015 Annual Meeting, which is scheduled for Thursday, January 22, 2015.

The Board of Directors met in person six times in 2014: January, March, May, July, September and December. The minutes of the Board of Directors meetings are available on the NCM website. The executive Committee traditionally meets on the months that the board of Directors does not meet.

The Executive Director served as a mentor for Leadership Little Traverse, a program sponsored by the Petoskey Chamber of Commerce, as well as a mentor for Leadership Charlevoix County, a program sponsored by the Charlevoix Chamber of Commerce.

NCM also participated in the Information Summit, which is sponsored by the Human Services Coordinating Body. The Summit was held on September 19 and provides an opportunity for those individuals involved with social service agencies to network and learn more about one another's services. Terri Sevener and Bert Rousseau staffed the NCM booth, while Jane Millar presented at breakout sessions.

The Executive Director defended NCM's grant applications before the United Way panel and served as a resource speaker in Ken Winter's International Relations class at North Central Michigan College. She facilitated one session of *Shoplifting Doesn't Pay*, which was held for the fourth graders at Central Elementary School in Petoskey, was conducted.

Caseload

The number of cases opened in 2014 as compared with 2013 was up by 216 cases: 728 vs. 512. This increase is primarily attributable to three factors. First, the pilot project with the 90th District Court in Emmet County is bringing almost all small claims cases to NCM. Second, the School Attendance Mediation Program is engaging the school districts to refer more cases to NCM. Three, the efforts and initiatives of promoting NCM in general seems to be paying off.

Breach of Contract continues to be the most prevalent type of case (52%). This is followed by cases involving divorce and domestics matters (13%). The third most common type of case relates to victim-offender reconciliation (8%) followed by parenting time (5%).



Agreement Rates

It should be noted that the "no agreement" rate in 2014 was down by 10% from 2013, and that conciliations were up by 20%. This is directly attributable to the fact that NCM is handling considerably more small claims cases. The fact that the agreement rate from 2013 to 2014 is down by 8% is also directly related to the number of small claims cases because small claims cases tend to be conciliated rather than mediated to agreement.

The agreement rate percentages for 2014 are depicted in the pie chart entitled Agreement Rates. The table below shows the comparison of agreement rates between 2013 and 2014.

Referral Sources

The pattern continues that the vast majority of cases are referred / ordered by the Court (86%). This percentage, however, is significantly higher than the percentage ordered by the courts in 2013 (75%). Much of this increase in the percentage of court referrals is directly attributable to the fact that all small claims cases are being ordered to mediation. With the increase in court referrals, self referrals dropped from 14% in 2013 to 7% in 2014.


The fact that the percentage of education institution referrals has dropped from 7% in 2013 to 4% in 2014 appears to be a temporary situation.



Fund Raising and Grants

The tenth annual Theatre Party was held on Monday, March 10. NCM budgeted \$10,000.00 in revenue and \$2,248.00 in expenses for a profit of \$7,752.00. In reality, \$10,784.50 was collected in revenue, and expenses totaled \$4,126.24 for a profit of \$6,658.26, which was \$1,093.74 under budget. Although ticket sales were up, sponsorships were down.

NCM does charge a minimal administrative fee for most cases. Those cases for which there is no charge are school attendance, access and visitation, victim-offender, special education, and small claims. Additionally, fees are waived if it would be a hardship for an individual to pay the fee. In 2014, NCM collected \$7,060.00 in fees from 128 individuals as compared to \$6,912.50 from 155 participants in 2013. In 2014, \$2,985.00 in fees was written off as uncollectable, as compared to \$1,620.50 in 2013. It is not surprising that the collection rate would be less desirable in 2014 over 2013 due to the fact that more fees were charged in 2014 than in 2013.

NCM received \$3,100.00 from the federal government for access and visitation cases, as compared to \$2,625.00 in 2013. In both cases, the amount received was the maximum that could have been received. For special education cases, NCM was awarded from the Department of Special Education \$2,500.00 in 2014 and \$1,000.00 in 2013.

Board Retreat

On Thursday, February 25, 2014, the Board of Directors met at the Weathervane Restaurant in Charlevoix for a board retreat. Thanks to the generosity of the Petoskey-Harbor Springs Area Community Foundation, NCM was able to contract with Pam Evans from NorthSky in Traverse City to serve as the facilitator of the workshop. By using the CCAT Assessment Tool, the core capacity of NCM was analyzed in four categories: adaptive capacity, leadership capacity, management capacity and technical capacity. The overall organizational culture of NCM had a score of 232. Any score of 230 or greater is considered to be strong. Although NCM was not weak in any of the four specific capacities, three challenges were identified: adapting to changes in program resources, finding proper facilities to run an efficient operation, and leadership sustainability.

In Kind Contributions

To a non-profit organization, in-kind contributions are significant for two primary reasons. First, when writing grant applications, in kind donations are considered a means of determining community support of the organization. Second, in kind donations help to defray expenses. The top six areas of contributions in 2015 related to the following:

The total amount of in kind contributions for 2014 was \$170,662.83, which is considerably below that of 2013, which totaled \$226,552.96. This directly relates to the fact NCM handled more small claims cases, which for the most part are conciliated by staff rather than mediated by the volunteer mediators. The in kind donations for 2014

constituted 48% of the total budget. The total in kind contributions attributable to the mediators themselves represented 83% of the in kind contributions.

Financial Analysis

With two exceptions, the year 2014 was a financially successful one for NCM.

Due to the fact that NCM has maintained more than sufficient funds in its Chase checking account over the years, it was decided to transfer \$10,000.00 from the checking account into the Northwest Bank account, which serves as the capital equipment replacement fund. Consequently, this \$10,000.00 coupled with the \$1,950.00 of depreciation causes the profit loss statement of the Chase checking account to shows a negative net income of \$4,438.13. Without these two line items, the NCM checking account would have shown a gain of \$7,511.34.

Attention also needs to be drawn to the fact the balance sheet shows \$2,204.84 less in 2014 than in 2013. This is the first time this has occurred in the past 12 years. Of the \$2,204.84, \$1,950.00 is due to depreciation.

Summary

The year 2014 was another outstanding year for NCM. It opened 728 cases and closed 702. This is the first time in the history of NCM that either one of these categories has exceeded 700. In that one of the components of the state formula for funding relates to the number of closed cases, this is particularly valuable.

NCM continues to be an exemplary Citizen Dispute Resolution Program center. In that it was rated the most efficient center in the state for 2014, NCM will receive the greatest percentage of the pooled funding (9.025%) from the State Court Administrative Office for 2015. The next closest center will receive 7.994%.

The year 2014 brought considerable growth in small claims cases and support of the School Attendance Mediation Program. The Honorable Jim Erhart from 90th District Court is now referring all small claims cases in both Charlevoix and Emmet counties to mediation. Additionally, the Charlevoix-Emmet Intermediate School District approached NCM with a proposal to collaborate on school attendance cases.

There are two aspects relating to personnel, both of which have positive and negative consequences. After almost nine years of service to NCM, Bert Rousseau resigned to accept a position with the Inland Lakes School District, an opportunity she could not pass up. Dixie Bunker has replaced Bert. With experience in a law office and being a paralegal, Dixie will have a positive impact upon the office. Due to term limits, NCM also lost six of its board members: President Lisa Hoyt, Vice-President Joel Wurster and board members Mary Faculak, Dr. Roger Postmus, Jim Raber, and Pat Seagmen. Joining the 2015 board are Treasurer Bill Meengs, and board members Ed Engstrom, Stuart Fenton, Kate Scollin, Pat Simmons and Christian Smith.

With the significant growth that NCM has seen during 2014, the biggest challenge it faces is determining whether or not this is an actual trend or if the 2014 caseload was a temporary one. If it is a trend, NCM needs to prepare itself for the potential of having to hire a new staff member. This could be problematic in that funding from SCAO is always in the rears and would not cover the cost of a new hire. Therefore, NCM would need to approach the local counties and courts for additional funding.

The bottom line is that the growth that NCM is seeing is good. NCM must, however, take the growth with a steady pace so that it can sustain its programs and services with qualify, efficiency and effectiveness.
