ANNUAL REPORT FOR 2015

Personnel

Northern Community Mediation (NCM) has three, full-time employees: two Case Managers and the Executive Director. NCM also employs a part-time Assistant Administrator.

In April, Kristy Whitman joined the NCM team as the Assistant Administrator. It was essential that NCM add a part-time person to the staff because of the caseload that has been rapidly and steadily growing over the past three years.

In August, Intake Coordinator Dixie Bunker was replaced by Case Manager Karen Cole. Karen is responsible for domestic relations, divorce, access and visitation, and guardianship cases. She also oversees the Victim-Offender, Reconciliation and Child Protection Mediation Programs.

In November, Case Manager Terri Sevener gave notice that she would be leaving NCM after four years of service so that she could take advantage of an opportunity with another company. She was replaced with Case Manager Kirstyn Horan, who began working for NCM on January 4, 2016. Kirstyn is responsible for small claims, general civil, property, and landlord/tenant cases

In addition to the paid staff, NCM has 62 volunteer mediators. The majority of the volunteer mediators have received advanced training in specialized fields of mediation. The table below depicts the areas of expertise along with the number of mediators qualified in those fields.

As can be seen, NCM has a sufficient number of mediators. The challenge facing NCM relates to the availability of the mediators. Many are retired or work full-time. Hence, they are either traveling or only available on a limited basis for daytime mediations. Additionally, more and more of the cases referred to NCM are complex and require specialized training.

NCM enforces the State Court Administrative Office (SCAO) requirement that mediators complete a minimum of eight hours of continuing education every two years. NCM also continues to be in compliance with the State Court Administrative Office (SCAO) policy for background checks. All employees, interns, volunteer mediators and other volunteers

must undergo a background check through the Michigan State Police (ICHAT), as well as a criminal registry check through the Department of Human Services every two years.

Trainings and Workshops

In 2015, NCM offered two trainings: 40-hour, general civil and eight-hour advanced.

Nineteen people participated in the 40-hour, general civil, 2.411 training, which was facilitated by Wanda Joseph. Of the participants, two were attorneys. Twelve of the 19 have become mediators for NCM and five for other Citizen Dispute Resolution Program (CDRP) centers.

In the fall, NCM offered a four-hour advanced mediation training, which was facilitated by Jane Millar. The topic of the workshop was *Agreement Writing*. The focus was to ensure that all agreements answer the questions *who*, *what*, *when*, *where*, *how* and *why*. Thirty-seven people participated in the workshop with 25 of them being mediators for NCM.

NCM also offered two mediator roundtables, one for School Attendance Mediation and one for the Victim-Offender Mediation Program. NCM staff also were trained by GovPayNet, an organization through which NCM could accept credit card payments. Although this service is now available to all clients, no one has yet to take advantage of this convenience.

NCM staff participated in professional development opportunities offered at sites other than at NCM. Terri Sevener and Karen Cole attended the Special Education Intake Training in Lansing, as well as the Intake Roundtable offered by the State Court Administrative Office in Lansing. Terri also attended the Little River Band of Odawa Peace Making Conference, and Karen Cole attended the Michigan Association of Court Mediators (MACM) annual conference. Karen Cole, Terri Sevener and Jane Millar attended the three-day Special Education Mediation Training in Mt. Pleasant. Jane Millar was a participant in the Michigan Bar Association, Alternative Dispute Resolution conference in Traverse City.

Meetings & Gatherings

In addition to regular meetings relating to the operations of NCM, the staff participates in a variety of specific meetings.

On January 22, 2015, NCM conducted its annual meeting for 2014. It was held from 12:00 pm to 12:55 pm at City Park in Petoskey, Michigan. Minutes of the 2015 annual meeting will be available on the NCM website (www.northernmediation.org) upon approval of the Board of Directors at the 2016 Annual Meeting, which is scheduled for Thursday, January 21, 2016.

The Board of Directors met in person six times in 2015: January, March, May, July, September and November. The minutes of the Board of Directors meetings are available on the NCM website. The Executive Committee traditionally met in February, April, June and October.

On December 8 from 4:30 pm to 6:00 pm, NCM held its annual holiday party. Everyone in attendance enjoyed food, beverage, conversation and friendship. At this event, two special things took place. Terri Sevener was recognized for her years of service to NCM. She was presented with a gift certificate from the Wine Guys restaurants. Additionally, Executive Director Jane Millar was surprised by the appearance of Lisa Blanchard and Amy Gillard from Women Who Care. They presented a check for \$6,000 to NCM.

Approximately 40 people attended the Appreciation Luncheon, which was held on Monday, May 18 at the Bistro in the Charlevoix Country Club. The Executive Director served as a mentor for Leadership Little Traverse, a program sponsored by the Petoskey Chamber of Commerce, as well as a mentor for Leadership Charlevoix County, a program sponsored by the Charlevoix Chamber of Commerce.

NCM also participated in the Information Summit, which is sponsored by the Human Services Coordinating Body. The Summit was held on September 18 and provides an opportunity for those individuals involved with social service agencies to network and learn more about one another's services. Karen Cole, Kristy Whitman and Jane Millar staffed the NCM booth. Additionally, Jane Millar presented a session on the School Attendance Mediation Program and its relationship to the Special Education Program.

The Executive Director defended NCM's grant applications before the United Way panel and was a guest speaker for a North Central Michigan College class on Conflict in the Workplace. She also scripted and produced the School Attendance Mediation Program video.

Caseload

The number of cases opened in 2015 as compared with 2014 was up by 99 cases: 800 vs. 701. This increase is primarily attributable to three factors. First, the pilot project with the 90th District Court in Emmet County has been expanded to include the 90th District Court in Charlevoix County. Second, the School Attendance Mediation Program is engaging the school districts to refer more cases to NCM. Three, the efforts and initiatives of promoting NCM in general seems to be paying off.

Breach of Contract continues to be the most prevalent type of case (64%). This is followed by cases involving divorce and domestics matters (12%). The third most common type of case relates to victim-offender reconciliation (5%) followed by parenting time (4%).



Referral Sources





Fund Raising and Grants

The eleventh annual Theatre Party was held on Monday, March 9. NCM budgeted \$10,785.00 in revenue and \$2,655.00 in expenses for a profit of \$8,130.00. In reality, \$10,373.00 was collected in revenue, and expenses totaled \$4,042.67 for a profit of \$6,330.33, which was \$1,799.67 under budget. Although sponsorships were up, ticket sales were down.

NCM does charge a minimal administrative fee for most cases. Those cases for which there is no charge are school attendance, access and visitation, victim-offender, special education, and small claims. Additionally, fees are waived if it would be a hardship for an individual to pay the fee. In 2015, NCM collected \$6,670.00 in fees from 107 individuals as compared to \$7,130.00 from 128 participants in 2014. In 2015, \$4,045.00 in fees was written off as uncollectable, as compared to \$2,985.00 in 2014.

NCM received \$2,500.00 from the federal government for access and visitation cases, as compared to \$3,100.00 in 2013. In both cases, the amount received was the maximum that could have been received. For special education cases, NCM was awarded from the Department of Special Education \$3,200.00 in 2015 and \$2,500.00 in 2014. The increase in funding from the Department of Special Education relates to the fact that the Executive Director has been aggressively presenting programs relating to the Special Education Mediation Program.

Board Retreat

On Monday, February 23, 2015, the Board of Directors met at the Weathervane Restaurant in Charlevoix for a board retreat. Margo Johnson and Chris Smith from SCORE facilitated the retreat. Three areas of concern were identified: resources/budget, facilities, and leadership sustainability/succession. Throughout the year, board members have worked with the Executive Director to address the challenges that are faced by NCM. John Marshall has agreed to spear head this initiative during the 2016 year.

In Kind Contributions

To a non-profit organization, in-kind contributions are significant for two primary reasons. First, when writing grant applications, in kind donations are considered a means of determining community support of the organization. Second, in kind donations help to defray expenses. The top six areas of contributions in 2015 related to the following:

The total amount of in kind contributions for 2015 was \$163.205.83, which is below that of 2014, which totaled \$170,662.83. This directly relates to the fact NCM handled more small claims cases, which for the most part are conciliated by staff rather than mediated by the volunteer mediators. The in kind donations for 2015 constituted 48% of the total budget, the same as in 2014. The total in kind contributions attributable to the mediators themselves represented 83% of the in kind contributions, also the same as in 2014.

Financial Analysis

Although it initially appeared that NCM might end 2015 in the red, such was not the case. Based upon cash flow, NCM ended 2015 with a gain of \$1,541.53. The balance sheet previous year comparison shows a loss of \$67.25, which is due solely to depreciation of equipment. In other words, NCM has again ended it fiscal year on solid ground.

Summary

The year 2015 was another outstanding year for NCM. It opened 767 cases and closed 800. This is the first time in the history of NCM that NCM disposed of 800 cases in one year. In that one of the components of the state formula for funding relates to the number of closed cases, this is particularly valuable.

NCM continues to be an exemplary Citizen Dispute Resolution Program center. In that it was again rated the most efficient center in the state for 2015, NCM will receive the greatest percentage of the pooled funding (8.252%) from the State Court Administrative Office for 2016. The next closest center will receive 7.709%.

The year 2015 brought considerable growth in small claims cases and support of the School Attendance Mediation Program. The Honorable Jim Erhart from 90th District Court continues to refer all small claims and general civil cases in both Charlevoix and Emmet counties to mediation. Additionally, the collaboration among the Charlevoix-Emmet Intermediate School District, the 7th Probate Court, DHHS, the school districts serviced by the Char-Em ISD and NCM continues to grow and become stronger.

Due to term limits, three of NCM's board members had to leave their positions at the end of 2015: Judge Maldonado, John Marshall, and Dr. Paula Welmers. All three have left a positive impact on NCM. Judge Maldonado researched available facilities for NCM, John Marshall served as a strong president of the board, and Dr. Welmers was an excellent secretary of the board. Coming onto the board in 2016 are four equally as dedicated individuals: Bill Banner, Mark Fralick, Mary Roberts, and Chelsea Townsend Platte. The officers for 2016 are as follows:

With the growth in NCM's caseload, NCM had to hire an additional staff person. Although Kristy is only part-time, her presence has made a world of difference. Being able to stay on top of its caseload is essential if NCM is to sustain its programs and services with quality, efficiency and effectiveness.

This does raise the issue of salaries. Even though NCM is not seeing an increase in its overall funding, it continues to struggle to provide its employees with competitive salaries and benefits, especially now that a fourth person has been added to the staff. This is precisely why NCM has lost two outstanding employees within a year. Both of these individuals had opportunities to make considerably more money at other companies.

The bottom line is that 2015 was an excellent year for NCM. In 2016, through the guidance of John Marshall, NCM will spend time focusing on its future facilities, resources, and leadership sustainability.
