REMINDER

If an agreement is reached at mediation, it is essential that it be written down and then signed by the involved parties. Without a signed, written document, NCM cannot declare that an agreement has been reached. In fact, quite the opposite is true. We have to enter that no agreement was reached. This policy comes from the CDRP office of the State Court Administrative Office.

Having a written agreement includes small claims cases. Having a notice of dismissal and/or a wage assignment order does not meet the standard without an actual written, signed document.

SURVEY RESULTS

On May 22, a survey was sent out to79 attorneys, court personnel and other individuals who work with Northern Community Mediation on a regular basis. The purpose was to determine how these individuals viewed our services. Forty-three people responded to the survey, which represents a 54.4% return rate. In terms of survey, a 10% return is considered to be excellent.

Based upon the survey results, NCM is providing excellent services. This is evidenced by the fact that the percentage of responses of "Always" and "Usually" combined is significant in all 20 questions. In the questions that have "Not Applicable" responses, the percentage totals for "Always" and "Usually" is somewhat skewed. The survey delineated between services provided by staff and those provided by the mediators.
