MONEY MAKES THE WORLD GO AROUND

Approximately one-fourth of Northern Community Mediation's funding comes from the State Court Administrative Office. In simple terms, for every court filing in district court, \$3.00 is set aside for the Citizen Dispute Resolution Program (CDRP). Of that \$3.00, \$2.00 stays local and \$1.00 is pooled money that is distributed among the 18 CDRP centers. The distribution is based upon a weighted caseload and number of disposed cases on a yearly basis. Although NCM receives the second least amount of the money that remains local in comparison to the other 17 centers, year-after-year, NCM receives the most or second greatest amount of the pooled funds.

Through the lobbying efforts of the association formed by the executive directors of the 18 centers, the legislature approved \$500,000 as a line item in the budget. It needs to be pointed out that those lobbying efforts were primarily accomplished by Elizabeth Giddings from the center in Holland. The \$500,000 has been distributed among the centers based upon the above described formula, which means that NCM received the second greatest amount, which totaled \$38,386.11. In that salaries and benefits for staff are nothing to brag about, these funds will be used to help supplement salaries and fringe benefits of staff.
