# FORTY HOUR TRAINING

Just a reminder that a forty-hour training for those interested in becoming mediators has been scheduled in June. Six dates are involved: the evening of Thursday, June 3; all day, Friday, June 4; all day Saturday, June 5; the evening of Thursday, June 10; all day Friday, June 11; and all day Saturday, June 12. The fees are as follows:

\$100 for those interested in mediating for NCM \$100 for potential mediators from other CDRP centers \$300 for those not planning on mediating for NCM Corporate group rates are as follows:

\$250/person for 2 to 4 people

\$200/person for 5 to 7 people

## **POLICY & PROCEDURE**

For the purpose of clarification, the following procedural issues are being addressed:

- Remember either to read verbatim or paraphrase the consent form prior to entering into the mediation process as such. This is important because everyone at the table needs to understand the essence of the consent form. It also is a safe guard in case one of the parties does not read.
- In the packet of materials you receive prior to mediation, there will be two stamps. One will say "original;" the other will say "counter copy original." When an agreement is reached, the original should be stamped as such. It should then be placed in the mediation packet of materials and returned to Pat Dull or placed in her office if she is not available. All copies of the agreement should be stamped "counter copy original."
- When you conduct an evening mediation or when no staff is at the office, after placing the mediation packet of materials in Pat's office, lock her door, and then push the key underneath the door.
