On February 1, the NCM board held its annual board retreat at the Weathervane in Charlevoix. The board members began the retreat by reviewing the Mission Statement and developing a Vision Statement. The proposed Vision Statement is as follows:

The Vision of Northern Community Mediation is to help as many people as possible resolve conflicts in Charlevoix and Emmet Counties

The revised, proposed Mission Statement is as follows:

The Mission of Northern Community Mediation is that all parties involved in disputes in Charlevoix and Emmet Counties use mediation as a means of resolving their conflicts.

This discussion was followed by making a distinction between, mediation, arbitration and litigation and then a review of the strategic plan. Judge Mulhauser then reviewed NCM's programs: Victim-Offender, Child Protection, School Attendance, First-Time-Offender Shoplifting and Preventative Shoplifting. A scripted, role play depicting an actual mediation was then enacted by Defendant Mary Roberts, Plaintiff Stuart Fenton and Co-Mediators Christian Smith and Jane Millar. Begin includes the initial greeting of the clients through the Opening Statement and the Consent to Mediate. Just remember that the Opening Statement should come before the Consent to Mediate. The reason for this is that the NCM Case Workers spend time developing a positive relationship with the parties so that they feel less threatened and apprehensive when they come to mediation. The Opening Statement is an opportunity for the mediators to capitalize upon those feelings in developing their relationship of trust with the clients prior to "getting down to the nitty-gritty" of mediation.
