#### GOVERNOR'S SERVICE AWARDS

On Monday, June 30, Governor Rick Snyder recognized five finalists in each of eight categories at the fourth-annual, service-awards ceremony, which was held at the Gem Theatre in Detroit. The Citizen Dispute Resolution Program (CDRP) was one of five finalists for the Outstanding Volunteer Program Award in the state of Michigan. Representing the CDRP were Doug Van Epps (Executive Director of the CDRP for the state of Michigan, Annette Wells (Executive Director of the Gaylord center), Bonnie Hanes (Executive Director of the Oakland center, and Jane Millar (Executive Director of Northern Community Mediation). Although the CDRP was not the winner of its category, the evening was one of celebration and festivities. #### SECURITY & EMERGENCY MANAGEMENT

Dennis Mac Donell, who serves as the Court Security Specialist with the Michigan Supreme Court, facilitated a Safety and Security Workshop from 9:00am to noon on Friday, June 20 at the Perry Hotel. The agenda included court security, personal safety, powers of observation, potentially violent situations and bomb threats. Based upon a visitation to the NCM office, Mac Donell also evaluated NCM's security and safety measures and made several recommendations. One of his suggestions was the installation of an alert system that would include an audio alert upon a person's arriving on the stairway landing going up the stairs to the NCM offices and a camera installed on the landing, the image of which would be viewable on the three computers of the staff. NCM is in the process of locating funding in order to implement his recommendations.

# THANK YOU REVENUE SHARING

Due to the fact that as of April 8, 2014 the Microsoft security patch would no longer cover Windows XP, it was essential that Northern Community Mediation replace all of its computers. The situation was best described as "running a computer with Windows XP would be like turning on your house's security system but leaving the doors and windows open." The estimate for the entire upgrade was \$5,592. Therefore, NCM requested \$4,734 from the Revenue Sharing Board to help defray the costs. Fortunately, the grant request was approved. So, a big thank you to the Revenue Sharing Board.
