CLARIFICATION

At a recent SCAO meeting, the issue of destroying notes upon completion of a mediation session was brought up. There seems to be some confusion as to what is the appropriate thing to do. In a memorandum to the Executive directors of the CDRP centers, Doug Van Epps, Executive Director of the Citizen Dispute Resolution Program for the state of Michigan, summarized the situation.

“An agreement to maintain confidentiality does not include a requirement of destroying notes....In short, while a mediator can certainly state that as an assurance of the mediator’s confidentiality she/he will destroy notes made in mediation, the requirement of parties’ destroying their notes lacks both authority and necessity.”

A huge thank you to all four of these organizations is definitely in order.
