SPEAKING OF PPMP

As of June 30, Northern Community Mediation will be the only funded PPMP program in the state of Michigan. SCAO can no longer afford to underwrite those programs that are marginal in their performance in relationship to permanency planning. Our program, however, is lauded by SCAO. The fact that NCM has been so successful while other centers have not is attributable to one component—Kathy Lame. If it were not for Kathy, we would probably be in the same boat as the other centers. Thanks, Kathy.

ORIGINAL AGREEMENTS

Based upon dialogue during a meeting with our judges and court administrators, NCM will maintain all original, signed agreements. Therefore, unless there are extenuating circumstances, the original agreements should be placed in the mediation packets and returned to Pat. Call if you have any questions. Small claims is an exception to this rule.

SPEAKING OF SMALL CLAIMS

As a reminder, each of the small claims courts has a packet which contains the following documents: CDRP 03 face sheet (yellow), Mediation Consent form, Mediation Follow-Up form, Wage Assignment Order. All cases that are mediated in small claims should include the first three documents in the case file. If an agreement is reached, it should also include a copy of the agreement, either a judgment or dismissal form, and a Wage Assignment Order if appropriate.

FORTY-HOUR TRAINING
