Navajo is a verb-centered language. Even adjectives have no direct translation into Navajo; descriptions are given through verbs. It's a prefix-heavy language, with 25 kinds of pronominal prefixes which can be stacked onto one another. This forms incredibly long phrases like chidí naa' na' í bee' eldohtsoh bikáá' dah naaznilígíí which means "army tank."
