## FEES FOR SERVICE

The Board of Directors has approved charging minimal fees for our services. For those cases that do not come through the courts, an administrative fee will be charged as described below:

- Breach of contract, consumer/merchant, landlord/tenant, neighborhood disputes \$30.00
- Divorce and domestic relations \$40.00
- Employer/employee, professional/client, property/real estate \$50.00

In all cases, if someone is unable to afford the fee, it will be waived.

As has been the protocol in the past, cases that are referred or ordered through the court will not be subject to these fees. We will, however, request a donation.

As mediators, your role in the process will be quite simple. There will be envelopes on the windowsills of the mediation rooms. All we ask you to do is draw attention to them by saying "If you have not already paid your fee or made a donation, envelopes are available on the windowsill." One more request. We would appreciate your sharing any feedback from our clients regarding our fee structure.
