## REMINDER

When you indicate that you are available to do a mediation at a specific time and date, the Case Manager then asks you if you know any of the involved parties. Obviously, if you do know any of the individuals, you withdraw from mediating the case. There are times, however, that you do not realize that you know one of the parties until you arrive at the mediation and see the individual face to face. If that happens, the best way to handle the situation is to apologize and say that you did not realize that you knew the specific person. If you feel you can mediate fairly without bias, say as such, but add that if any of the parties would prefer you not mediate, then withdraw yourself from the case. The mediation can continue with the one mediator or make use of a staff member if available.
