REMINDERS

- 1. Everyone at the mediation table should sign the Consent to Mediate. This includes the mediators.
- 2. Only the parties involved in the agreement should sign the Agreement. Mediators should not sign the Agreement.
- 3. Even if there is not a full agreement, but the parties agree to anything, be certain to put that in writing. The reason for this is that NCM is evaluated by the state on the percentage of agreements and partial agreements reached. Unless there is something in writing, NCM cannot state that an agreement or partial agreement has been reached. This includes anything, no matter how minor, to which the parties agree.
- 4. When writing an agreement that involves a judgment or dismissal, be certain to include who will deliver that document to the court.
- 5. In the opening statement, in certain circumstances it would not be a bad idea to state that although showing up for mediation meets the court requirements, we would hope that everyone would mediate in good faith.
- 6. Refrain from asking if the parties at the table have ever participated in mediation previously.
