#### SCHOOL ATTENDANCE MEDIATION

In last month's newsletter, reference was made to the fact that Northern Community Mediation is partnering with the Pellston School District in a pilot project relating to school attendance mediation. The idea is to identify students who are showing signs of poor school attendance, and then by bringing the students, their parents and appropriate school officials together through mediation develop a plan of action to improve the behavior, truancy will be avoided, grades will improve, and general attitude will change. In other words, this is a preventative approach that will enhance the students' learning experiences.

Although details are still being worked out, if you are interested in participating in this program, call Jane at 487.1771. It will be necessary to take a special, half-day training in order to do the school attendance mediations. The date for this seminar is yet to be determined.

#### REMINDER

- 1. All papers that need to be shredded should be placed in the shred folder upon completion of mediation.
- 2. All consent agreements and other relevant documents should be returned in the packet. There have been incidents where mediators have inadvertently scooped up those documents.
- 3. Often the names of the participants are entered into the computer prior to mediation for the convenience of the mediators. When this is the case and one of those individuals listed does not show up yet the mediation goes forward, remember to delete that individual's name from the form.
- 4. Make certain everyone at the table signs the Consent to Mediate form

#### INTERESTING NUANCE

We had a situation arise where one of the attorneys at the table signed the agreement on behalf of his client, who had left the mediation table early. There was no document indicating that the attorney had settlement authority. This raised the question as to whether or not the agreement would be binding.

Based upon advice from SCAO, "It appears that an agreement signed by a party's attorney is binding as to the attorney's client." This may not be the smartest action on the part of the attorney since it could lead to possible claims against the attorney down the road, but it is not our place as mediators to question the action.
