President's Report,

Ted reported that Pat Seagmen needed to step down from Executive Committee, but would still remain on the Board. He discussed openings on the Board and areas we were looking for representation. He reported the Executive Committee had performed reviews on the Executive Director and the reviews were very positive.

Executive Directors Report, presented by Jane Millar:

- 1. Case Report Cases closed (379) are down a bit from last year (382), 30 fewer cases closed because of time to close the cases, this will impact funding for next year.
- 2. Fees for service \$1925 is overdue, \$300 just was billed and \$480 are pending cases.
- 3. Evaluation Results Jane shared copies of the Mediator remarks on annual evaluation of NCM.
- 4. 40 Hours Training will be costly, \$5000, bringing in new trainers.
- 5. PHSACF Report Jane shared financial statements for the funds at both Foundations, for PHSACF six month period April 1 September 30, 2010 and the Charlevoix County Community Foundation dated January 1 September 30, 2010.

- 6. Board & Administrator Article Jane shared article regarding Executive Director communications with the Board.
- 7. Mediator Roundtable is scheduled for Nov. 9.
- 8. 28 People had made reservations for the Nov. 17 dinner at Birchwood.
- 9. Staff Retreat to take place December 10.
- 10. Holiday party to take place December 12.
- 11. Persons of the Year Awards will be presented at future luncheon instead of Holiday Party.
- 12. Mediator Times Jane presented chart showing the number of mediations and hours of mediation and value by separate mediators.
