Executive Director's Report: Jane Millar

SCAO opportunities – GVSU is doing an updated Child Protection study where we are assisting in the data collection to determine the effectiveness of mediation services in the child protection realm. Also, WMU is will be studying data from a school restorative justice initiative, where funding will be provided for 2 part time mediators in local public schools to assist in conflict resolution. Schools selected are likely to be E Jordan and Pellston. This is a 13 month, 1 time only grant provided by SCAO. Platte suggested that if successful, we could incorporate the principles and practices into existing positions within the school.
