A RECORD YEAR

It was the busiest year in NCM history. The Case Managers opened 1,045 cases and closed 1,051 cases. Of the closed cases, 576 were ordered by the courts, and 160 referrals were from the schools. The most common dispute type was Breach of Contract, which included everything from small claims to general civil cases. The second most common dispute type was school related, and the third most common was divorce. Eighty percent of the cases came to full or partial agreement. This could not have happened without the dedication and support of all of you who mediate for NCM. Congratulations and thank you for a phenomenal 2017.
