#### RESTORATIVE PRACTICES TRAINING

Recent legislation has ordered that all school districts must implement a Restorative Practices (RP) Program in their schools. The goal of this initiative is to approach students with a proactive, restorative approach rather than a reactive, punitive one. This is right in line with the pilot project involving Pellston High School and Boyne City High School, which was a part of a grant from the State Court Administrative Office (SCAO) and overseen by Western Michigan University.

In order to implement RP Programs, trainings re being offered to school personnel. Executive Director Jane Millar recently participated in one of those trainings for the purpose of understanding how the educational community was going to approach the initiative. The training took place over two days and was facilitated by Roy Burton. It was excellent.
