### MONEY MAKES THE WORLD GO AROUND

The state legislature has approve \$425,000 as a line item in the state budget to go towards the Citizen Dispute Resolution Program. This funding will be divided among the 18 CDRP centers in the state based upon a weighted caseload formula. This funding is a direct result of the CDRP center directors meeting with their state representatives and lobbying for the cause. This additional funding, however, does not replace the legislative piece that designates a percentage of court filing fees going towards the CDRP program.

## **SNEAKY! SNEAKY! SNEAKY!**

Every once in a while, one of the mediation parties will try to record via his/her cell phone what is being said at the mediation table. Just keep your eyes open and be on the lookout if someone has a phone that could be recording the proceedings.

#### YOUR SAFETY IS AT STAKE

Three NCM policies to keep in mind:

- The use of personal cell phones by staff, mediators or board members to conduct NCM business is prohibited.
- As a mediator, giving your last name to participants in mediation is prohibited.
- Distribution of person business cards is also prohibited. The reason for these policies is for your protection. Occasionally, there are participants who can be quite volatile, and we do not want them to have a means of tracking you down.
