TWO REPORTS

Between October 2016 and June 2018, Northern Community Mediation was involved in two, state-wide studies: Child Protection Mediation(CDP) and Restorative Practices (RP). The results of those two studies are now posted at http://www.northernmediation.org/reports/ on the NCM website. In both cases, the results demonstrate the value of these programs. By using mediation rather than the traditional court process, CDP cases resulted in a time and cost savings to the courts, improvement in relationships between parents and government agencies, a shorter time span to permanency, and higher parental compliance. RP cases resulted in a decrease in suspension days, fewer absences, less tardiness, and a decrease in the need for disciplinary action. Additionally, when the infraction involved an agreement between the students and the school, in 89% of the cases the students upheld the agreements that they had made.
