Thanks to the support of four local Kiwanis Clubs (Boyne City, Charlevoix, Harbor Springs and Little Traverse Bay), Northern Community Mediation (NCM) has created an anti-bullying, activity workbook for kindergarten through fifth grade students. Executive Director Jane Millar is in the process of distributing the workbooks to each of the elementary schools within the Charlevoix-Emmet Intermediate School District service area. So far she has met with the staffs at Blackbird Elementary, Charlevoix Montessori Academy, Concord Academy Petoskey, Ellsworth Elementary, Lincoln Elementary, St. Francis Elementary, St. Mary in Charlevoix, and Shay Elementary. The focus of the activity book is to give students the tools and courage to "stand up" for the person being bullied rather than being a bystander. In other words, bullying hurts everyone and bullying is not okay.

FOR YOUR INFORMATION

It has been brought to the attention of the staff that mediators may not be aware of some of the NCM policies.

- The following wording appears in the confirmation letters that go out to all participants prior to mediation. "Please, note that NCM maintains a smoke free and weapons free environment. In addition, no recording devices are allowed in mediation."
- NCM carries malpractice/liability insurance coverage for its mediators.
- Mediators cannot be forced to testify about what is said in mediation. As a point of clarification, however, they can be subpoenaed. This means that the mediator would have to appear in court, but once there, the court would uphold the confidentiality rule. If a NCM mediator were to be subpoenaed, he/she should contact NCM immediately so that we could arrange for an attorney to be present in court with the mediator.
- It has been suggested that we re-evaluate the wording relating to confidentiality in the Consent to Mediate, NCM staff will do so at the Staff Retreat in November/

The retreat gives the staff an opportunity to evaluate services rendered, determine effectiveness of programs, review forms and documents, and set goals for the following year.
