CLAIRIFICATION

There are two perspectives of thought on satisfying a court order to mediation. The one school of thought is that if a person is ordered to mediation by the court, all he/she has to do is to enter the mediation room and then can leave. After all, he/she has shown up. The other school of thought is that when a person is ordered to mediation by the court, he/she has an obligation to mediate in good faith. Different judges interpret this differently. Therefore, take note of this, and be careful not to mislead anyone who comes to mediation. From NCM's perspective, the Case Manager informs the court in one of several ways:

- Case was mediated with an agreement
- Case was mediated with a partial agreement
- Case was mediated with no agreement
- Party did not show
- Party refused to mediate
