Dear NAME:

Two seventeen-year-old boys were traveling on a two-lane road—one going south, the other going north. The young man traveling south crossed the yellow line and hit the car of the young man traveling north. The young man who caused the accident was found guilty of DUI manslaughter—a felony that could have resulted in a sentence of 15 years in prison, considerable fines and a lifetime revocation of his driver's license.

Prior to his sentencing, the prosecuting attorney asked permission to approach the bench. "Your honor, nothing will be served by putting this young man in jail. If both sets of parents would agree, would you consider sending this case to mediation to determine restitution?" All of the parties involved agreed to do so.

At mediation, the young man listened to the anguish of the parents of the boy who had been killed. He had to hear them say, "We will never see our son graduate from high school or college. We will never see our son get married. And since he was our only child, we will never have the joy of grandchildren."

The young man then listened to his own parents tell of the devastation the accident had done to their family. How it had impacted his siblings. How they were tormented knowing that their son had caused someone's death. How they could not fathom the sorrow of the parents of the boy that was killed.

It then became time to determine the fate of the young man. The parents of the boy who was killed turned to the young man who was responsible for the death of their son and said, "We cannot bring our son back. What is done is done, but if his life is to have any meaning, our desire is that you turn your life around. We want you to graduate from high school with all As and Bs. We want you to graduate from college. We want you to stay off drugs and alcohol. We want you to check in with us quarterly. We want you to understand the anguish you have caused us and your family. We want you to become a responsible human being."


