CDRP EVALUATION

The State Court Administrative Office (SCAO) is in the process of conducting a comprehensive evaluation of the Citizen Dispute Resolution Program (CDRP). Part of that evaluation involves a visitation of the 18 CDRP centers by Harry Mika, the researcher. On Thursday, January 30 and Friday, January 31, he interviewed 41 individuals at Northern Community Mediation over the two-day period. The participants represented mediators, board members, community leaders, legal professionals and staff. All of the research will result in a comprehensive report titled "An Evaluation of Michigan's Community Dispute Resolution Program at 30 Years: Appraising the Past, Assessing the Present, and Planning the Future." A preliminary version of the report will be available on May 1.
