ANNUAL REPORT FOR 2021

Personnel

The year 2021 continued to function in the COVID-19 mode. Although the staff was working in person at the office, Coronavirus protocols continued to be enforced. Since all three staff members had been vaccinated and then boosted, they were not required to wear masks. Any other individuals who happened to come to the NCM office, however, were required to be masked and maintain a six-foot distance from others.

Not enough accolades can be said about the staff in their handling of the challenging situation. All mediations continued to be held via zoom or through conciliation on the telephone. These praises extend to Northern Community Mediation's (NCM) volunteer mediators. Without their willingness to mediate via Zoom, NCM would not have been able to offer its services to the citizens of Charlevoix and Emmet counties.

NCM presently has 57 mediators. The majority of the volunteer mediators have received advanced training in specialized fields of mediation, which include the following:

- Advanced General Civil
- Behavioral Health
- Child Protection
- Divorce/Domestic Relations
- Guardianship
- Mental Health
- Parenting Time
- Restorative Practices
- Safety & Security
- School Attendance
- Special Education
- Victim-Offender Reconciliation

NCM enforces the State Court Administrative Office (SCAO) requirement that mediators complete a minimum of eight hours of continuing education every two years. NCM also continues to be in compliance with the State Court Administrative Office (SCAO) policy for background checks. All employees, interns, volunteer mediators and other volunteers must undergo a background check through the Michigan State Police (ICHAT), as well as a criminal registry check through the Department of Human Services every two years.

Trainings and Workshops

NCM conducted seven mediator trainings in 2021 with executive Director Dr. Jane Millar as the trainer. All trainings were offered via Zoom.

Two four-hour, advanced mediator trainings were available primarily for the NCM mediators. The first one, which was titled "The Mediator's Health & Well-Being," generated \$625. Twenty individuals participated in the training: 11 who mediate for NCM, four for the Mt. Clemens center, three for the Eastern Upper Peninsula center, one for the Macomb center, and one private mediator. Those individuals who mediate

exclusively for one of the Citizen Dispute Resolution Program (CDRP) centers were charged \$25, whereas the private mediator was charged \$150.

The second four-hour training, which was titled "Parenting Time & Divorce/Domestic Nuances" was offered in June and generated \$1,025. Mediators who work exclusively with one of the CDRP centers were charged \$25, and those who do private mediations were charged \$100. Seven participants mediate for NCM, four for the Sault Ste. Marie center, two for the Marquette center, two for the Muskegon center, one for the Grand Rapids center, one for the Kalamazoo center, six who do not mediate exclusively for a CDRP center, and three for whom there was no charge, for a total of 31 participants.

The Oakland Mediation center contracted with NCM to conduct two, four-hour, advanced mediation trainings, each one's being "The Mediator's Health & Well Being." Thirteen mediators participated in the September 10 training, and 13 in the September 24 training. NCM was paid \$550 for each of the trainings.

The 40-hour, general civil training, which is the basic training required to be a mediator in the state of Michigan, brought in \$3,850 in revenue. There were sixteen participants: eight who will be mediators for NCM, four for the Muskegon center, one for the Flint center, one for the Grand Rapids center, and two who will be private, attorney mediators. Those participants who will mediate exclusively for one of the CDRP centers were charged \$50 each, while those participants who will do private mediations were charged \$600 each. Additionally, NCM received \$2,000 from the Behavioral Health Mediation Service Grant to offer the 40-hour training.

NCM also conducted two, six-hour Behavioral Health Mediation trainings, for which NCM was paid \$300 each. These two trainings relate to the Behavioral Health Mediation Services Program, which is the result of a Michigan Department of Health & Human Services (MDHHS) grant award to the Michigan Community Mediation Association (MCMA) to work collaboratively with Community Mental Health (CMH) in providing mediation services to clients of CMH.

Meetings

On January 21, 2021 NCM conducted its annual meeting for 2020 via Zoom. Minutes of that meeting will be available on the NCM website (www.northernmediation.org) upon approval by the Board of Directors at the 2022 Annual Meeting, which is scheduled for Thursday, January 20, 2022.

All Board and committee meetings were conducted via Zoom. Regular board meetings were held six times in 2021: January, March, May, July, September, and November. The Board called a special meeting in December to approve the proposed 2022 budget. Minutes of the board meetings are available on the NCM website. The Executive Committee met five times in 2021: February, April, June, August, and October. The other four standing committees met throughout the year on an as-needed basis. Those committees are as follows: facilities, funding, marketing and staff compensation.

On Thursday, May 27, NCM held its annual, Appreciation Gala via Zoom. Doug Van Epps, Executive Director of the Office of Dispute Resolution (ODR) under the State Court Administrative Office (SCAO) was the guest speaker. He reflected on his 30 years of service as the CDRP director for the State Court Administrative Office (SCAO) and

the changes that have occurred and the progress that has been made over the years. The following individuals were recognized for their contributions to NCM:

- Veteran Mediator of the Year Bill Cattin
- Rookie Mediator of the Year Jeanne Baranowski
- Advocate of the Year Which Wich Team, which included Mitch Brown, Rich Sylvester, Nikki Devitt, and Maureen Hollocker, as well as Bob Banner, Laura Buckingham, Karen Cole, Hugh Conklin, Iza Babinska, Phil Harmon, Emily Hoffman, Hob Ingleson, Brooke Jacoby and her daughter Preston, Suzi Kanine, Brian Kasiborski, and Marty VandeCarr
- Leah Award Doug Van Epps. This award recognizes an individual or organization that has significantly contributed to mediation and the CDRP over the years and is not necessarily given every year.

In addition to regular meetings relating to the operations of NCM, such as weekly staff meetings and a yearly staff retreat, the staff has traditionally participated in a variety of meetings and gatherings. As a result of COVID-19, most events were cancelled, such as the Chamber Expos, Project Connect and Career Day. NCM staff did participate in those meetings and events that were held via Zoom, such as monthly meetings of the Human Services Coordination Body (HSCB), the Great Start Collaborative and Connecting Women in Business, as well as yearly events, such as Breakfast for Champions and the Chambers of Commerce State of the Community, as well as their annual meetings. NCM staff also maintained contact with various agencies and individuals through Zoom meetings, telephone conversations and e-mails. Since October NCM staff has contacted at least five individuals per month to promote the BHMS Program and posted at least twice a month on Facebook and Instagram. This same approach will begin for the Michigan Agricultural Mediation Program in January 2022.

The Executive Director continues to be a mentor for Leadership Charlevoix County. In order to capitalize upon the knowledge of the younger generation, she has met with teacher Matt Hamilton from East Jordan High School and teacher Molly Jones from Alanson High School. Their classes will be developing short videos promoting NCM that will be posted on NCM's Instagram pages. The Executive Director was extended a personal invitation to the investiture of Judge Jennifer Deegan and was both surprised and honored on September 16 when the Charlevoix-Emmet Bar Association presented her with the Liberty Bell award.

On Thursday, December 16, 2021 from 5:00 pm to 6:00 pm, NCM again made use of Zoom by hosting its annual holiday party. Fun was had by all. The Executive Director started by saying, "Let's pretend that I could give each of you \$500,000 to donate to one non-profit of your choice (other than NCM). Which non-profit would you choose and why?" What an interesting conversation and what a variety of answers, ranging from the environment to housing to food banks to humanitarian needs! Following this thought provoking conversation, a light-hearted scavenger hunt was held. Twenty items were listed that could potentially be found in everyone's home. Of the 20 items, mediator Suzy Engle was able to find 19. All she was missing was the mistletoe. Her big prize was a \$10 gift certificate to Julienne Tomatoes.

Of all of the outreach performed by the staff, the most enjoyment relates to Women Can/Women Do, a fundraiser for the Women's Resource Center. This event is attended

by approximately 500 women in the Petoskey area. NCM is involved by being one of the table designers. This year's theme was "The Teddy Bears' Picnic."

State-Wide Involvement

The Executive Director continues to be active in the Michigan Community Mediation Association (MCMA). She attends monthly meetings of the Board of Directors, Development Committee and the Finance/Funding Formula Committee. Additionally, she was asked to participate in the Michigan Community Mental Health Summit and attended the Alternative Dispute Resolution (ADR) Section of the Michigan State Bar Association (MSBA) annual conference. All of these events were held via Zoom

Following the November election, the executive Director contacted all newly elected officials, which included the Emmet county commissioners, the Charlevoix county commissioners, and state representatives of Charlevoix and Emmet counties. Representative John Damoose showed particular interest in mediation as was evidenced by the fact that he spent over 90 minutes at the NCM office.

Board Retreat

The board held its annual Board Retreat via Zoom on Monday, February 8. The major outcome of the retreat was the establishment of four committees along with their responsibilities that will be used as NCM's strategic plan.

- The Facilities Committee will be responsible for investigating alternatives for the NCM office, specifically focusing on upgrading the present facility at NCM's expense, locating another facility for rent and the possibility of purchasing its own building. Mitch Brown and Hugh Conklin serve on this committee as cochairpersons.
- The Funding Committee was charged with analyzing the efficiency of the present sources of income, such as the Theatre Parties, as well as investigating new sources of revenue. Iza Babinska, Nikki Devitt, Emily Hoffman, Brian Kasiborski and Maureen Hollocker serve on this committee with Kirstyn Horan as its chairperson.
- The Marketing/Public Relations Committee will focus on the use of social media in promoting NCM. In particular, the Executive Director will work with Sommer Poquette of Keep It Real Social in the development of its Facebook and Instagram pages, as well as the use of a Blog. Chaired by Suzi Kanine, this committee consists of Phil Harmon, Hob Ingleson and Brooke Jacoby.
- The Staff Compensation Committee's charge was to investigate salaries for the case managers and the executive director in comparison to equivalent positions in four areas: 1) in comparison to the other CDRP centers with similar budgets; 2) in comparison to other non-profits within Charlevoix and Emmet counties; 3) in comparison to other non-profits in northern Michigan; and 4) in comparison to non-profits throughout the state of Michigan with similar budgets. Additionally, this committee was to look at the fringe benefit package as described in the Personnel Policies Manual.

Staff Retreat

On Friday, November 12, Northern Community Mediation (NCM) held its annual staff retreat. Case Managers Karen Cole and Laura Buckingham along with Executive Director Jane Millar spent a short time reviewing the accomplishments and challenges of 2021. They then focused on the agenda, which included the following: 2022 calendar, monitoring calendar, fees, mediator list & qualifications, weighted caseload, succession plans, and update of forms, personnel policies, office procedures and MADTrac.

Presentations and Promotion

As stated earlier, presentations and promotional activities were hindered by COVID-19. Therefore, most interactions were on a one-to-one basis via phone conversations. The one exception related to Connecting Women in Business, for which NCM was a sponsor. Hence, NCM staff was able to make a short presentation about the organization and its value to the community.

MI-Resolve

MI-Resolve, an initiative of the SCAO, is an online service that provides a free, quick and easy way to resolve disputes with the help of a neutral mediator. Just as in a face-to-face mediation, the mediator helps parties find a solution to a dispute that works best for everyone. The only difference is that the mediation is done online by using a platform similar to e-mails. In that MI-Resolve is a secure system, all communication is confidential. If an agreement is reached, appropriate paper work is drawn up, and that agreement is considered to be a contract, enforceable by law.

Unfortunately, this opportunity has not been embraced by the citizens of Charlevoix and Emmet counties. Since the platform is limited to small claims types of cases and since both the Charlevoix and Emmet County Courts have such an efficient system in place for small claims cases, it appears that there is no real need for MI-Resolve. Once MI-Resolve has been expanded to include parenting time types of cases, it is the hope of NCM that the convenience of the platform will entice clients to use MI-Resolve

Eviction Diversion Mediation Program (EDMP)

The EDMP was established throughout the state to avoid massive evictions that could result in a significant increase in homelessness, a scenario that was predicted could occur due to the pandemic. The premise is that state funds would be used to pay the landlord 90% of what was owed to him/her. In return, he/she would not evict the tenant. Although the CDRP centers downstate were swamped with EDMP cases, such was not the case for NCM and the other smaller centers in more rural areas. In fact, no EDMP cases were referred to NCM.

Behavioral Health Mediation Services Program (BHMSP)

The Michigan Department of Health & Human Services awarded a grant in the amount of \$500,000 to MCMA with the Oakland Mediation Center serving as the fiscal agent for the purpose of providing mediation services to clients of Community Mental Health (CMH) who have a grievance with their treatment plan or who would like to have their

treatment plan re-evaluated. The training for the mediators for this specialized type of mediation has been completed, and the plan is to have the CMH case workers trained during the first quarter of 2022. Once this is completed, BHMSP mediations will begin. Not only will the grant pay each CDRP center for each case mediated, the centers are also paid \$1,050 per month for conducting at least five meetings and two social media posts per month.

Michigan Agricultural Mediation Program (MAMP)

The United States Department of Agriculture (USDA) has awarded the MAMP to MCMA. This program offers free mediation services to Michigan farmers to resolve their disputes outside of court. Farmers' disputes covered by this grant can range from contract issues, estate and probate complications, adverse determinations by the USDA, bankruptcy, and any other conflict they may face concerning their farm. It can also cover divorce and domestic matters. For each MAMP case that one of the CDRP centers mediates, it will receive \$200 from the grant. Since this grant was announced less than two months ago, NCM is still in the process of promoting and creating awareness of the program.

Caseload

The number of cases opened in 2021 as compared with 2020 was down by 267 cases: 395 vs. 662. The number of cases closed in 2021 as compared to 2020 was down by 264 cases: 404 vs. 668. This drop directly relates to the pandemic and the loss of the Restorative Practices Program at Boyne City High School, which accounts for 283 cases. If those 283 cases were added to the 2021 total cases closed, there would have been 687 closed cases for 2021.

Accounting for 39.11% of the cases, breach of contract mediations were the most prevalent types of cases in 2021. This was followed by divorce cases at 14.6%. School attendance cases accounted for accounted for 7.43% of the cases and domestic at 5.2%.



Agreement Rates

Throughout 2021, all mediations were conducted via Zoom. In 2020 three-fourths of the mediations were held via Zoom, whereas in 2019, all mediations were in-person. In comparing the agreement rates among the three years, it appears that not having in-person mediations has had an impact upon the agreement rates. It is also interesting to note that conciliations rose significantly from 2019 to 2021.

The agreement rate percentages for 2021 are depicted in the pie chart entitled Agreement Rates. The table below shows the comparison of agreement rates between 2021, 2020 and 2019.

The number of court referred / ordered cases dropped from 462 in 2019 to 319 in 2020. This was due primarily to the fact that court filings in general dropped as a result of COVID-19. It is anticipated that this trend will continue well into 2022.





<u>Fees</u>

NCM does charge a minimal administrative fee for most cases. Those cases for which there is no charge are school attendance, access and visitation, victim-offender, special education, and small claims. Additionally, fees are either reduced or waived if it would be a hardship for an individual to pay the fee. If a client is an American Veteran, fees are waived for all parties involved in the case.

Access & Visitation (ACVS) fees, which come from federal funds, had a \$3,000 cap for 2021. From year to year, Special Education fees, which come from Special Education Mediation Services (SEMS), have dropped because the elven school districts in the Charlevoix-Emmet Intermediate School District prefer to handle their own special education cases rather than going through SEMS.

Collection of Fees

NCM sent out reminder notices for overdue payments to 59 individuals. 69% of those individuals paid their bills, whereas 31% did not respond. The 31% of those who did not respond accounted for 18 individuals who were sent third notices. Of the 18, 39% paid, whereas 61% did not respond. Following a third notice without payment, NCM considers the potential payment as a write off.

Financial Impact of Agreements

Although many of the cases mediated by NCM do not involve any sort of financial restitution or settlement, financial issues and commitments are either central or secondary in certain types of cases, such as divorce or breach of contract. In 2021, NCM mediated \$8,021,615.08 worth of settlements.

Donations

NCM had the most successful donor campaign in its history. Although the year-end financials show an income of \$12,940, the actual amount contributed as of January 11,

2022 was \$17,055. The difference lies in the fact that \$4,115 was deposited into the checking account in 2022.

Grants

NCM received a total of \$10,949 in grants from five different sources.

- The Charlevoix County Community Foundation reimbursed NCM for three mediations involving Charlevoix County American Veterans for a total of \$600.
- The Petoskey-Harbor Springs Area Community Foundation awarded NCM \$2,800 to contract with Sommer Poquette of Keep It Real Social for the purpose of expanding NCM's social media presence.
- The Rotary Club of Petoskey provided funds so that NCM could purchase Owl Meeting, a hardware that allows all participants in a room to be seen simultaneously on the computer screen as one unit rather than individual squares.
- The Michigan Department of Health & Human Services (MDHHS) awarded the Michigan Community Mediation Association with the Oakland Mediation Center as the fiscal agent \$500,000 to develop and implement the Behavioral Health Mediation Services (BHMS) Program. These funds are being distributed among the 17 Citizen Dispute Resolution Program (CDRP) centers through reimbursement for promotion and mediations. Presently, all centers receive monthly payments of \$1,050 for promotion of the program.
- The Women's Organization contributed \$500 to go towards payment of \$250 to each of two classrooms for the development of an Instagram/TicToc video promoting NCM.

In Kind Contributions

To a non-profit organization, in-kind contributions are significant for two primary reasons. First, when writing grant applications, in kind donations are considered a means of determining community support of the organization. Second, in kind donations help to defray expenses. The top four areas of contributions in 2021 related to the following:

The total amount of in kind contributions for 2021 was \$125,751.02, which is equivalent to that of 2020, which totaled \$127,079.08. The in kind donations for 2021 constituted 55% of the total budget. The total in kind contributions attributable to the mediators themselves represented 82% of the in kind contributions. It should be noted that NCM paid no rent for the Charlevoix office space in 2021 because of COVID-19.

Financial Analysis

There is no question about it, NCM's finances continue to be negatively impacted by COVID-19. Although 2021 ended in the black, it is likely that 2022 will end in the red unless \$24,217.42 is carried over from 2021 into 2022. This possibility is not surprising. It has been anticipated as a possibility since 2020.

However, all is not doom and gloom. NCM is in a financial position to weather the storm, if there actually ends up being one. For the past 19 years, NCM's balance sheet previous year comparison has been stable and continued to grow. The table below shows that growth in assets:

Summary

The year 2021 was even more challenging than 2020. Yet, there were many positives.

- The staff has continued to adapt to the new way of doing business and has even embraced the advantages of doing so.
- The mediators also have continued to adapt. In fact, many of the mediators who
 were reluctant to mediate via Zoom are now willing to make use of the
 technology.
- The Board has been exceptionally proactive. The four committees (facilities, funding, marketing and staff compensation) have made significant contributions to the progress of NCM.
- The Board recognizes the value of the NCM staff and unanimously supported a significant increase in staff salaries.
- COVID-19 has forced the use of technology like we have never seen before. In doing so, it became apparent that expenses could be cut in areas such as postage, mileage, printing and supplies
- The use of technology such as Zoom for meetings, mediations and retreats has advantages, such as convenience and the ability to screen share. The end result is that the future will often consist of hybrid mediations (combining in-person with Zoom).
- The Michigan Community Mediation Association (MCMA), of which NCM is a member, is recognized as a leading force in the state of Michigan, as is exemplified by its having been awarded the Behavioral Health Mediation Services (BHMS) and the Michigan Agricultural Mediation Program (MAMP) grants.
- The Oakland Mediation Center (OMC) contracted with NCM for its Executive Director to facilitate two trainings for the OMC mediators.
- The MCMA contracted with NCM for its Executive Director to facilitate two trainings for mediators who will b facilitating BHMS cases.
- The MCMA contracted with NCM for its Executive Director to facilitate two trainings for mediators who will b facilitating BHMS cases.

The year 2022 will be a challenging one. Since the overall funding for 2022 is down, diligence will have to be practiced in relationship to expenses. It will also be critical to increase the caseload during the year so that the State funding for 2023 does not decline more than it did for 2022.
