On March 19, Governor Gretchen Whitmer announced the appointment of Jennifer "Jenny" Deegan to serve as the 57th Circuit Court Judge in Emmet County. Jenny is stepping in to complete the term of Judge Charles Johnson, who retired at the end of last year. Currently, Jenny practices family and criminal law as a partner with Nelson, Deegan, Forster & Stikovich, PC. Prior to that she was with Stroup Meengs, PC, was the assistant prosecuting attorney in Charlevoix County, Wayne County, and Sanilac County. She will be only the second judge to serve as judge of the 57th Circuit Court. In describing Jenny, one of the first words that comes to mind is "fair."
