1. Proposed Board Governance Policies Change

## New language proposed:

In the event there is a resignation or death of a board member during his/her term or if there is not a total of 15 board members at any given time, the board may choose to add new board members throughout the year. The process for doing so would be as follows: 1) The name of a proposed candidate(s) would be presented by a board member at a regularly scheduled board meeting; 2) The Executive Director would obtain bios and pictures of the proposed candidate(s) and send that information to the board members; 3) At the following board meeting, the board would vote on the proposed candidate(s); 4) If approved, the term for the new board member(s) would commence immediately as of January of the year in which the vote was taken.

Board discussed language clarification for the fourth part of proposed language and asked the Executive Director to clarify and table approval of the language to the September meeting.

## Proposed Bylaw Change

## New language proposed:

The board may also add additional board members throughout the year as long as the nomination(s) is made at a regularly scheduled board meeting, the board receives a picture and bio of the candidate(s) prior to the next regularly scheduled board meeting, and the vote for approval is taken at the regularly scheduled board meeting following the board meeting at which the nomination(s) was made.

Hugh Conklin made the motion to accept the change, Brian Kasiborski seconded.

## 2. Future Board Meetings

Board members discussed the need to have in-person meetings, but also appreciate the flexibility in attending meetings virtually. The Executive Committee will discuss this at the August meeting and will bring a recommendation to the whole board at the September meeting.

# 1. <u>Public Relations/Marketing - Suzi Kanine</u>

Main focus should be public awareness of Northern Community Mediation. Discussion that using Facebook ads is one of the biggest means in which they could do that. They ads are efficient and cheap. Would like to schedule next meeting in August.

## 2. Facilities - Mitch Brown & Hugh Conklin

The committee met with St. Francis Church's finance committee to thank them for the relationship we have had and to help steward future relationships with the church. They shared that NCM is considering a capital improvement update in facility, which would include new carpet, flooring, bathrooms, overall making the space more ADA compliant. In exchange, NCM would ask that there would be a longer-term commitment for NCM to occupy the space. The committee is also exploring the opportunity to move into another facility in Petoskey.

## 3. Staff Compensation – Bob Banner

The committee discussed the possibility of an annual cost of living adjustment and an end of year bonus, if funding allows. Executive Director must present possibilities for board approval by the November meeting.

### 4. Funding – Kirstyn Horan

This committee met the need for a donation button to be visible on NCM's website. This can be used in social media via a QR code. The committee will also establish NCM with an AmazonSmile account. Additional ideas include: summer donor campaign, mediator legacy gifts, creating a mediator survey to gather information to use in donor campaigns and social media, and approaching local attorneys to establish a monthly gift.
