STATEWIDE CDRP ANNUAL REPORT

The summary of the CDRP annual report is available at https://www.northernmediation.org/wp-content/uploads/2022/07/State-CDRP-Annual-Report-2021.pdf on the NCM website. Some of the highlights of the report are as follows:

- 69% of mediated cases reach an agreement.
- The average amount per settlement is \$5,191.
- The average days to disposition are 27.
- The average duration of a mediation is 1.4 hours.
- For general civil, agreements are kept in 82% of the cases
- For family division, agreements are kept in 71.8% of
- For education-related, agreements are kept in 88.1% of the cases.
- The 17 CDRP centers handled more than 23,000 cases in 2021.
- The market value of the volunteer services of the CDRP centers equals more than \$1.8 million.

The report also highlights the fact that 90% of participants are satisfied with the use of Zoom. Additionally, in 2022 MI-Resolve will expand to include more than two-party disputes, disputes involving parenting time and the presence of attorneys
