#### GENTLE REMINDER

The question is "What if?" What if what? In writing the agreements for a mediation, the question "what if" should always be asked. "What if one of the parties fails to keep the agreement?" If the parties on their own do not include that in their agreement, as the mediator, it is advisable to ask the parties the "what if" question and include that as part of the agreement. Having said that, as the mediator, you cannot force them to have a "what if" clause in the agreement. All you can do is pose the idea.
