### HOW TO HANDLE A SUPPORT PERSON

For clarification purposes, a support person is someone who is there to lend support to one of the parties. Generally speaking, a party will request a support person when he/she does not have legal representation. The support person may be in the mediation itself, but usually is in another room. If the support person is in the mediation room, he/she must sign the Consent to Mediate, but must understand that he/she is not allowed to participate whatsoever in the conversation at the mediation table. If the support person tries to participate in the dialog, it is the responsibility of the mediator to remind him/her of the "rules" governing a support person.

The process of a support person's being present at mediation is as follows:

- A party requests a support person prior to mediation.
- The Case Manager contacts all of the other parties to see if there are any objections.
- If there are no objections, the request for a support person is granted.

If a party arrives with a support person without having received prior approval and if any of the parties object to the presence of that support person, he/she should be asked to leave. If it is an in-person mediation, the Case Manager will generally be here to help with that awkward situation.
