





# Income and Expense by Month January through December 2023





#### **ANNUAL REPORT FOR 2023**

#### Personnel

2023 was a challenging year for the Northern Community Mediation (NCM) staff. Case Manager Karen Cole resigned from NCM the middle of July. In searching for her replacement, NCM was fortunate to find a qualified replacement for Karen. Kurt Grangood has a background in education with a Master's Degree in Education and Leadership. He has been a teacher, principal and superintendent. Prior to Kurt's coming onto the NCM team the end of August, however, Laura saved the day by handling all of the NCM cases for the six weeks interim.

With Kurt's experience in education, the NCM staff took advantage of the situation to reassign responsibilities. Laura covers divorce, domestic and parenting-time cases, while Kurt handles small claims, general civil, employment, guardianship, property, real estate, school attendance, victim-offender reconciliation and special education.

NCM presently has 45 active mediators. The majority of the volunteer mediators have received advanced training in specialized fields of mediation, which include the following:

- Advanced General Civil
- Agricultural
- Behavioral Health
- Child Protection
- Divorce/Domestic Relations
- Guardianship
- Parenting Time
- Restorative Practices
- School Attendance
- Special Education
- Victim-Offender Reconciliation

NCM enforces the State Court Administrative Office (SCAO) requirement that mediators complete a minimum of eight hours of continuing education every two years. NCM also continues to be in compliance with the State Court Administrative Office (SCAO) policy for background checks. All employees, interns, volunteer mediators and other volunteers must undergo a background check through the Michigan State Police (ICHAT), as well as a criminal registry check through the Department of Human Services every two years.

#### Mediations

NCM provides its mediation services in four methods. Of the closed cases in 2023, 40% were via Zoom, 30% were in person, 29% were via phone and 1% was via MI-Resolve, which is an online option.

#### Trainings and Workshops

In the fall, NCM offered six workshops via Zoom that focused on the Michigan Court System. Each of the workshops were scheduled for 90 minutes.

- On October 12, the Honorable Joe Hayes from 33<sup>rd</sup> Circuit Court covered an overview of the Michigan Court System.
- On October 19, the Honorable Jennifer Deegan from 57<sup>th</sup> Circuit Court discussed the circuit court system.
- On October 20, Director Amanda Guarisco explained the Friend of the Court intricacies.
- On October 27, the Honorable Valerie Snyder from 7<sup>th</sup> Probate Court and Emmet County Court Administrator Matt Miller focused on the probate court system.
- On November 3, the Honorable JoAnne Cook discussed the Tribal Court.
- On November 17, the Honorable Angela Lasher from the 90<sup>th</sup> District Court and Emmet County Civil Clerk Wendy Viles focused on the district court and small claims.

This series of workshops was lauded by everyone involved—the participants as well as the presenters. In 2024, NCM hopes to arrange for a workshop on the Federal Court System, as well as work with Judge Cook to do a presentation at tribal headquarters in Harbor Springs.

#### Meetings

On January 19, 2023 NCM conducted its annual meeting for 2022 at City Park Grill in Petoskey. Minutes of that meeting will be available on the NCM website (<a href="www.northernmediation.org">www.northernmediation.org</a>) upon approval by the Board of Directors at the 2024 Annual Meeting, which is scheduled for Thursday, January 18, 2024.

Three of the regularly scheduled board meetings (January, March, May, July, September and November) were via zoom and three were in-person. Minutes of these meetings are available on the NCM website. The Executive Committee met on the months that the board did not meet. Additionally, the board did an electronic vote in December to approve the 2024 budget with 100% participation and unanimous approval. Throughout the year, there were several closed session board meetings that related to the purchase of the condominium and personnel issues.

Board committees, which consisted of facilities, funding, investment, Mediation Celebration, outreach, bi-annual newsletter and personnel met regularly throughout the year. The bi-annual newsletter is chaired by Bill Cattin, and he is the one who deserves full credit for both the spring and fall issues of *Community: It's Our Middle Name*.

On Thursday, May 25, NCM held its annual Appreciation Gala at Palette Bistro in Petoskey. Mediators, board members, donors, the bar association and NCM supporters in general were all recognized. The special awards were given to the following:

- Veteran Mediator of the Year Lee Kramer
- Rookie Mediator of the Year Tina Verlinden
- Leah Award Dan McGuire
- Advocates of the Year Mark Andresky & Mitch Brown for all that they did to make the purchase of NCM's new "home" come to fruition

A true highlight of the evening was the recognition of Connie Saltonstall for her 20 years of service as a mediator for NCM.

In addition to regular meetings relating to the operations of NCM, such as weekly staff meetings and a yearly staff retreat, the staff has traditionally participated in a variety of meetings and gatherings: Human Services Coordinating Body (HSCB), Great Start Collaborative, Chamber Expos, Connecting Women in Business, Women Can/Women Do, Celebration of Champions, Chamber States of the Community, Career Day and Project Connect. Additionally, the staff continues to make at least five contacts per month promoting the Michigan Agricultural Mediation Program and the Behavioral Health Mediation Services Program. Additionally, the Executive Director continues to be involved with both Leadership Charlevoix County and Leadership Little Traverse. In addition, she serves in an advisory capacity on the JEWEL Scholarship Committee at North Central Michigan College.

#### State-Wide Involvement

The Executive Director continues to be active in the Michigan Community Mediation Association (MCMA). She attends monthly meetings of the Board of Directors and the Executive Committee. Additionally, she is involved with the Alternative Dispute Resolution (ADR) Section of the Michigan Bar Association as co-chair for a statewide collaboration between the ADR Section and the MCMA in the development of statewide templates for training, such as Fundamental Mediation Skills followed by specialized trainings, such as general civil, divorce/domestic, parenting time. Rather than using the term Advanced Mediator Training for the eight-hours that are required every two years, the term would be changed to Continuing Education Units.

#### **Board Retreat**

The board held its annual Board Retreat at The Weathervane in Charlevoix on Wednesday, February 8. Jenny Brower gave a report on the new fundraiser that would ultimately be called Mediation Celebration, and Mitch Brown gave an update on the purchase of the condominium property. There were three breakout sessions to discuss funding and the capital campaign, marketing and fundraising. The most significant piece of business that occurred at the retreat was the board's authorizing the Executive Director to be the "designated signatory on behalf of Northern Community Mediation for the purchase of Units 3 and 4 located at 2202 Mitchell Park Drive in Petoskey, Michigan 49770 in the amount of \$220,000."

From a personal perspective, the Executive Director wants to express how much she appreciated the Terrace Inn gift certificate that the board gave to her. "It was frosting on the cake of my dream of NCM's owning its very own piece of property."

#### Staff Retreat

On Tuesday, November 14, Northern Community Mediation (NCM) held its annual staff retreat. Case Managers Laura Buckingham and Kurt Grangood along with Executive Director Jane Millar spent a short time reviewing the accomplishments and challenges of 2023. They then focused on the agenda, which included the following: 2024 calendar; monitoring calendar; fees; mediator list & qualifications; setting dates for two, mediator roundtables, a 40-hour Mediator training, review of office procedures and personnel policies; updating of forms; inventory; job descriptions and setting cleaning days. The

staff retreat for 2024 will be on Tuesday, November 19 and will again be held at NCM rather than at a separate room in a restaurant.

#### Presentations and Promotion

Whenever the opportunity arises to promote NCM and the services it offers, full advantage is taken of the offering. In 2023, most of the promotion was done through meetings with individuals or small groups rather than presentations to larger groups of people. In satisfying the requirements of the BHMSP grant, 76 meetings, 3 vendor tables, 12 presentations, and 24 posts were made during 2023 featuring NCM and the BHMSP grant. There were 74 meetings, 15 presentations, 3 vendor tables and 24 posts to promote NCM and the MAMP grant as well.

#### MI-Resolve

MI-Resolve continues to be a challenge. NCM still strives to entice involvement in the process. As was stated earlier, only 1% of the cases closed in 2023, which accounted for a total of two cases, used MI-Resolve.

#### Behavioral Health Mediation Services Program (BHMSP)

NCM continues to be involved with the BHMSP through the Michigan Community Mediation Association (MCMA). As a partner in this initiative, NCM receives \$1,250.49 per month from the grant. To receive this funding, NCM must include at least two social media posts per month and make at least five presentations/meetings per month relating to the program.

#### Michigan Agricultural Mediation Program (MAMP)

The United States Department of Agriculture (USDA) has awarded the MAMP to MCMA. This program offers free mediation services to Michigan farmers to resolve their disputes outside of court. Farmers' disputes covered by this grant can range from contract issues, estate and probate complications, adverse determinations by the USDA, bankruptcy, and any other conflict they may face concerning their farm. It can also cover divorce and domestic matters. For each mediation involving farming issues, NCM receives \$200. In 2023, NCM conducted two such mediations for a total of \$400. As in the BHMSP grant, NCM and all of the other CDRP centers have minimum requirements to meet.

#### Caseload

The number of cases opened in 2023 as compared with 2022 was down by 47 cases: 360 vs. 407. The number of cases closed in 2023 as compared to 2022 was down by 55: 362 vs. 417.

Accounting for 37.02% of the cases, breach of contract mediations were the most prevalent types of cases in 2023. This was followed by divorce cases at 14.64%, parenting time at 8.84%, landlord/tenant at 8.01%, domestic matters and property both at 5.80%, probate matters at 4.42%, child protection, school attendance and victim offender

all at 3.59%, and criminal, employment, guardianship, neighborhood and real estate making up the remaining 1.37%.



#### Agreement Rates

Of the closed cases in 2023, 40% were via Zoom, 30% were in person, 29% were over the telephone and 1% was online. In 2022, NCM was cautiously coming out of COVID and did conduct 12% of its cases in person. Throughout 2021, all mediations were conducted via Zoom. In 2020, three-fourths of the mediations were held via Zoom, whereas in 2019, all mediations were in-person.

The agreement rate percentages for 2023 are depicted in the pie chart entitled Agreement Rates. The table below shows the comparison of agreement rates between 2023, 2022, 2021, 2020 and 2019.

It would be premature to draw any definitive conclusions relating to the method of mediation and its relationship to agreement rates. It is worth noting, however, that the agreement rates are highest via Zoom, followed by the agreement rates when conciliations are conducted over the phone. The lowest agreement rate is when the mediation takes place in person.

#### Referral Sources

The number of court referred / ordered cases dropped from 293 in 2022 to 272 in 2023. This was due primarily to the fact that court filings in general are down.





#### **Fund Raising**

COVID had a significant impact upon fund raising, not only for Northern Community Mediation (NCM), but also for all non-profits. The bottom line is that most fund raising events did not take place in 2020, 2021, nor 2022.

Thanks to the genius of board member Jenny Brower, NCM introduced a new fundraising idea in 2023. Entrance to Mediation Celebration, which was held in the community room at the Emmet County Fairgrounds, was a \$25.00 gift certificate from a store, restaurant or other establishment in Charlevoix or Emmet counties. Those gift certificates were bundled into groups of ten and then people bought raffle tickets to win the bundles. A complete report of the event is available in the NCM documents under Mediation Celebration, including the finances, which showed a gain of \$5,812.94. It is anticipated that the 2024 Mediation Celebration will be much more profitable and since the overall event was highly successful, plans are already underway for holding Mediation Celebration on Thursday, June 20, 2024.

#### Fees

NCM does charge a minimal administrative fee for most cases. Those cases for which there is no charge are school attendance, access and visitation, victim-offender, special education and small claims. Additionally, fees are either reduced or waived if it would be a hardship for an individual to pay the fee. If a client is an American Veteran, fees are waived for all parties involved in the case.

Access & Visitation (ACVS) fees come from federal funds, and Michigan Agricultural Mediation program (MAMP) fees come from the United States Department of Agriculture. Since the eleven school districts within the Charlevoix-Emmet Intermediate School District service area prefer to handle their own special education cases, fees received for this service are minimal at best.

#### Collection of Fees

NCM sent out reminder notices for overdue payments to 39 individuals. 79% of those individuals paid their bills, whereas 21% did not respond. The 21% of those who did not respond accounted for eight individuals who were sent third notices. Of the eight, none paid. Following a third notice without payment, NCM considers the potential payment as a write off.

#### Financial Impact of Agreements

Although many of the cases mediated by NCM do not involve any sort of financial restitution or settlement, financial issues and commitments are either central or secondary in certain types of cases, such as divorce or breach of contract. In 2023, NCM mediated 71 cases involving distribution of money, which totaled \$2,331,296.30.

#### Donations

Again, NCM received significant donations in 2023. Although the donor campaign was slightly below budget, that difference was more than made up for by donations designated for relocation expenses. Individuals from the community, both community foundations and the Emmet-Charlevoix Bar Association were all very financially supportive of NCM in 2023.

#### In Kind Contributions

To a non-profit organization, in-kind contributions are significant for two primary reasons. First, when writing grant applications, in kind donations are considered a means of determining community support of the organization. Second, in kind donations help to defray expenses. The top four areas of contributions in 2023 related to the following:

The total amount of in kind contributions for 2023 was \$140,439.91, which is greater than the in kind attributable to 2022. This difference is due primarily to the in kind relocation expenses in 2023.

The in kind donations for 2023 constituted 32% of the total budget. The total in kind contributions attributable to the mediators themselves represented 83% of the in kind contributions.

#### Financial Analysis

In preparing the budget, the anticipation was that 2023 would be a year similar to pre-COVID years. There was no indication that NCM would be purchasing an office condominium. Consequently, the financial reality of 2023 is anything but close to the approved budget. Expenses relating to the purchase of the property were not limited to the purchase price alone. There were relocation expenses, property taxes for the first year only, condominium assessments and dues, and new air conditioning units and furnaces to name a few non-budgeted line items. Fortunately, NCM was in a financial position that it did not have to hesitate in going forward with the sale. Although expenses far exceeded both the total income and the operation income, NCM's balance sheet has never been stronger.

The table below shows the bottom line of the balance sheet from year to year.

#### Summary

The year 2023 was exhilarating, exciting, excellent, exacerbating and exhausting. It was an outstanding year for NCM. There were two initiatives that stand out, the most obvious one's being the purchase of condominium units 3 and 4 at 2202 Mitchell ark Drive in Petoskey. Bill created *Community: It's Our Middle Name*, a bi-annual newsletter that went out in the spring and again in the fall. This has been so well received that NCM will continue to publish the newsletter *Community: It's Our Middle Name*.

As we settle into our new location, all indications are that 2024 will be another successful year.
