

BOARD OF DIRECTORS' MEETING MINUTES July 13, 2023 at 12:00pm Zoom

1. May 11, 2023, 2023. Motion by Cyndy seconded by Bill to approve the May 11, 2023 meeting minutes. Motion passed in a unanimous voice vote.

TREASURER'S REPORT: Mark Andresky reported that financials look good. Current year to date shows a 10k deficit, which was expected due to expenses of the new building. Also expected is the possibility of not receiving 35k for employee retention funds from the state by the end of year. If this is the case, funds will need to be pulled from working capital. Current working capital is about 10 months; so, there are no concerns with this. Mark concluded by noting that financials for the new building, and the capital campaign will be added to the balance sheet. Motion by Kirstyn seconded by Lisa to accept the Treasurer's Report. Motion passed in a unanimous voice vote.

PRESIDENT'S REPORT: Kirstyn Horan- No report

COMMITTEE ASSIGNMENTS: Jane Millar reviewed the committee assignments noting that she combined the Executive and Staff Compensation committees, and renamed Marketing as Outreach. There was discussion regarding the Chairperson for the Capital Campaign Committee. Kirstyn recommended to appoint Judy as the chair but that the committee can discuss further at their next meeting who should be the Chair and the possibility of cochairs.
