- 2. Bi-Annual Newsletter Jane Millar reported for Bill Cattin that the fall/winter issue is largely complete and will be going out in November. There was some discussion regarding a digital issue in the future and a sign-up button on the website.
- 3. Capital Campaign Judy Zorn reported that the goal of the capital campaign will be \$200,000. The committee will be asking board members to assist with the three phases of the campaign by making a donation of any amount, suggesting names of possible major donors, and talking to the public about the campaign. The committee hopes to reach 60% funded by the end of February 2024. There was some discussion regarding video advertising and planning gatherings down the road.
- 4. Facilities Mitch Brown suggested looking into a maintenance plan with Ballards for the newly installed HVAC systems. Jane will look into that.
- 5. Funding Jane Millar reported for Bill Cattin that there will be no theater party in 2024 to focus on capital campaign. But it will return in 2025.
- 6. Investment Mark Andresky (covered in previous discussion).
- 7. Mediation Celebration Jenny Brower reported that the net profit from Mediation Celebration was over \$6,000, which she was happy about. Jenny reported that next year there will be less costs so the net profit should increase. She also reported that the Rusty Saw will provide all the food, for purchase, next year.
- 8. Personnel- Mitch reported that an official job application has been created for NCM. There is also now an exit interview process and form. The committee is currently working on a grievance policy.
