## YOU ASKED, WE ANSWER

At the annual meeting in January, it was reported that those cases that were mediated in person had an agreement rate of 46%, cases mediated via Zoom had an agreement rate of 62%, and those cases conciliated over the phone had an agreement rate of 55%. These data surprised most everyone in attendance. Most people thought that in person mediations would have had the highest agreement rate. Mediator Renee McDuffee raised the question, "Within each of these three categories, what were the percentages of the different types of disputes?" Here is the answer to that question.

With a total agreement rate of 46% for in-person mediations, the breakdown is as follows:

28% - Divorce with Children

27% - Parenting Time

14% - Divorce without Children

11% - Landlord/Tenant

7% - Victim/Offender

7% - Small Claims

3% - Property

3% - Real Estate

Agreement rate of 62% for mediations via Zoom:

26% - Parenting Time

13% - Divorce with Children

11% - Child Protection

11% - School Attendance

11% - Victim/Offender

7% - Divorce without Children

7% - Estate

6% - Property

4% - General Civil

2% - Custody

2% - Small Claims

Last, but not least, with an agreement rate of 55%, conciliations over the phone:

97% - Small Claims

3% - Landlord/Tenant
